GUIDELINES AND ELIGIBILITY REQUIREMENTS

Maximum of \$12,000.00 in scholarship money will be awarded to assist dependents of employees of member firms of the Ohio Valley Chapter of ReMA in pursuing his or her undergraduate/postsecondary education.

Eligibility Requirements

In order to receive a scholarship an applicant must meet the following eligibility requirements:

1. An applicant must be a dependent of an employee of an active member firm in good standing. Member firms are those firms directly affiliated as an *active member*. Subsidiary firms or any other type of operation that is not an active member of the Ohio Valley ReMA Chapter are not included.
2. An applicant must be scholastically qualified for acceptance by a college, university, or trade school.
3. An applicant must intend to pursue studies at an educational institution designated to meet the requirement for an academic or professional degree conferred by a college, university, or trade school.
4. Scholarships may be awarded on a continuing basis; however, the applicant must submit a full scholarship application with all required attachments each year. The amount, if any, to be awarded for continuing scholarships will be determined annually.
5. The applicant may attend any college, university, or trade school he/she chooses. Any costs over and above the amount of the scholarship or costs related to changing institutions must be paid by the applicant.
6. In the event an applicant does not complete the full year of school, any refunds allowed must be refunded to the Ohio Valley Chapter of ReMA.
7. Dependents of the scholarship committee are not eligible to receive a scholarship.

Required Attachments

1. Completed application form.
2. A transcript for the last semester or quarter and the prior year.
3. A letter of application which should include:
 - a. Complete personal history of school activities, extracurricular activities, accomplishments, contributions to community, hobbies, and personal goals.
4. Information demonstrating financial need including family income. A copy of your completed FAFSA (free application for federal student aid) application for the 2025-2026 academic year may be used to meet this requirement.

Recommended Attachments

The following additional documentation is recommended and may be included with the application or may be sent directly to the scholarship committee chairman.

1. A letter from the employer recommending the applicant and giving the employees job description and job history.
2. Letters of recommendation from teachers and other persons not related to the applicant (no more than three).

Selection

The selection of the scholarship recipients will be made by the Recycled Materials Association Committee, based solely on objective and nondiscriminatory criteria but not limited to:

- 50% for financial need. A letter including information demonstrating financial need to be included with the application.
- 50% for merit
 - o The applicant should have a grade point average of 2.8 or higher, unless outstanding special talent can be determined by the committee.
 - o A letter from the applicant which includes a personal history summarizing school activities, accomplishments, extracurricular activities, contributions to community, hobbies, and personal goals must be included in the application.
 - o The application may include recommendations from teachers and other persons not related to the applicant.
