

**Information for ReMA New England Chapter Scholarship 2026 Applicants:**

1. Three (3) individual scholarships are available for the 2026-2027 calendar school year. Each is valued at \$3000
2. The awarded scholarship can be used for certificate/degree programs at trade/technical and vocational schools as well as two-year or four-year post-secondary institutions.
3. Scholarship awards will be paid directly to the institution of choice, not to the student, so it is the recipient's responsibility to keep the New England Chapter Scholarship Chair apprised of any changes to their plans.
4. Submissions will not be returned to the applicant. Applicants are responsible for maintaining a copy for their files.
5. The applicant may attend any institution as outlined above of his or her choice; however, any charges above the amount of the scholarship will be the applicant's responsibility.
6. The New England Scholarship Committee will select the scholarship recipients based on merit (refer to the required document section for merit criteria). Recipients will be notified in writing by early summer 2026.
7. Applicants must be the employee or dependent of an employee of a member organization of the ReMa New England Chapter that is in good standing. A dependent is anyone who is part of the employee's household (e.g., children related by blood, step children, adopted children, etc.). This employee should have a minimum of six months of service with the member company.

**Voting Team**

1. The voting team will be comprised of current members of the New England Chapter Scholarship/Outreach Committee.
2. In the case a voting team member is related to an applicant, this member will excuse themselves from the entire process (beginning to end).
3. In the case of a tie, another board member or past president without an employee or dependent applying will be asked to review applications and vote.
